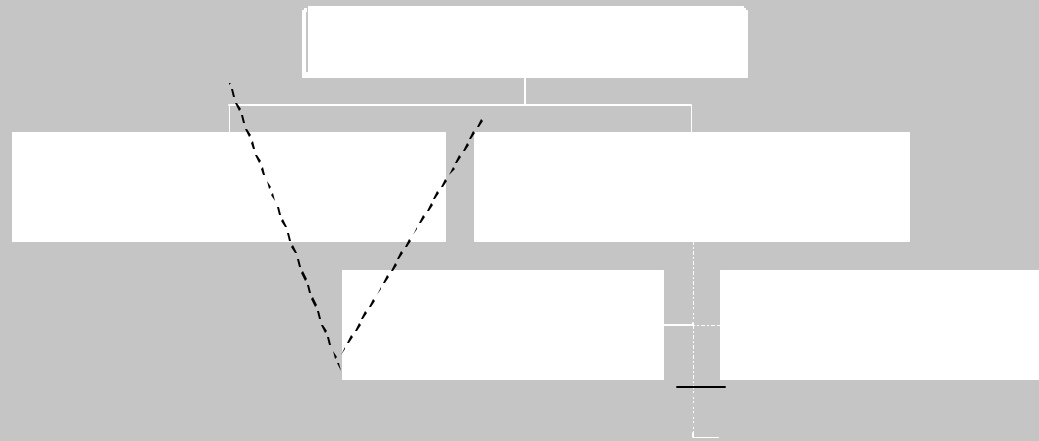

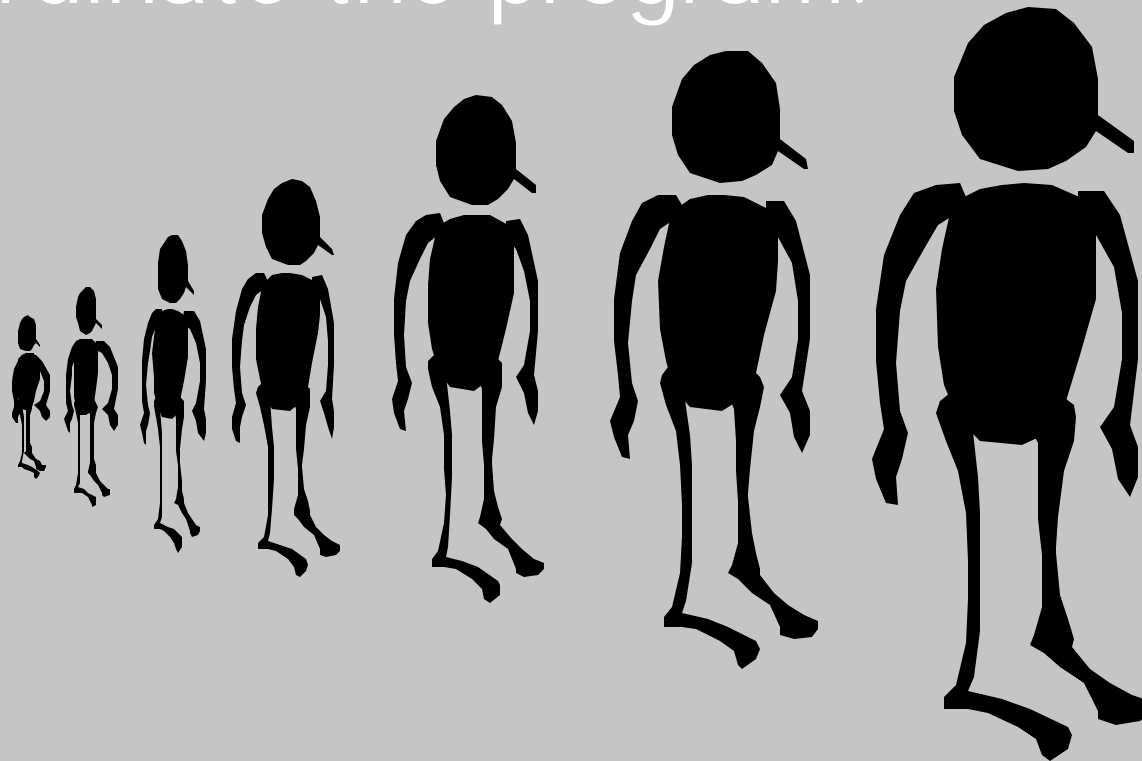
PURPOSE OF PTO

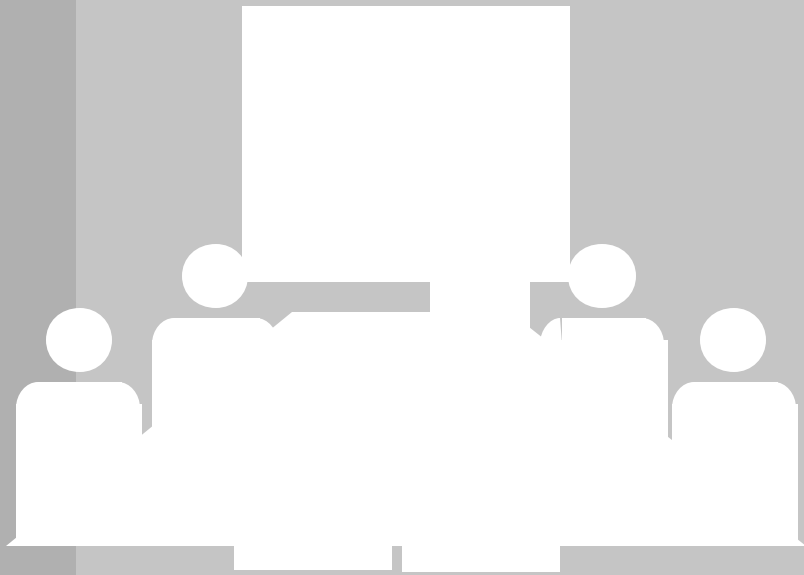
